The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did  
 The defendant was driving a silver 2014 Infinty 4-door (FL TAG #JRUC61) westbound on Platt St W, then turned southbound onto Howard Av S. This section of Platt St W is a 1-way road with eastbound traffic only and this section of Howard Av S is a 1-way road with northbound traffic only. During the traffic stop for driving the wrong way on both 1-way roads, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, largely dilated pupils, blank/dazed stare, droopy eyelids, slurred speech, he was confused & disoriented, appeared tired/lethargic, moved with slow & uncoordinated movements, was wearing a yellow nightclub wristband (left wrist), admitted to drinking 2 mixed vodka drinks while at a work party at the American Social Club (Howard Av S / Platt St W), and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, the defendant said that he would refuse to provide a breath sample, so he was read Implied Consent. Afterwards, he refused to provide the requested sample of breath.
