The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/13/2019 at 0328 hours I responded to Hoover BI S and Kennedy BI W after TPD dispatch received a call that there was a male passed out in a black vehicle facing the wrong way on Kennedy BI W. Upon my arrival I observed that a black 2011 Honda Fit compact SUV, FL tag HHXB87 was stopped on the raised median of Kennedy BI W facing oncoming W/B traffic. I then positioned my patrol in front of the Honda Fit so that it would not roll into oncoming traffic. After positioning my vehicle in front of the Honda Fit I observed defendant Johnson in the driver seat with his head down, as if he were sleeping. Then as I approached the defendant's vehicle on foot I could hear that the engine was still running. I then knocked on his driver side window and the defendant woke up. I then asked the defendant to put his vehicle in park and turn off the engine and he complied. At this time I observed that he had extremely bloodshot glassy eyes and I detected a very strong and distinct odor of an alcoholic beverage. The defendant then stated that he had "one drink". I then asked the defendant to exit his vehicle and he complied. He then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0345 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to submit to a breath test. Implied Consent was read at 0419 hours. I identified the defendant with a valid FL DL.
