 On listed date, time, and location, Trooper K. Ray (1418) observed the subjects vehicle traveling at a high rate of speed and changing lanes. Trooper Ray pace clocked the subjects vehicle at 103 miles per hour (MPH) in a posted 70 MPH zone. A traffic stop was conducted.
