

morning and if she had any contact with Aaron Silberberg.



Ms. Scharphre agreed to provided a sworn written statement. In summary she provided the following information: Ms. Scharphre stated that on 03/01/2021 she was outside by the school bus loop area picking up children, who were being dropped off between 0800 to 0830 hrs. Ms. Scharphre advised that at approximately 0815 hrs, Aaron Silberberg dropped [REDACTED] in the [REDACTED] circle. Ms. Scharphre was certain that the person who dropped off student [REDACTED] was Aaron Silberberg, based on the prior interactions she has had with him in the drop off circle. According to Ms. Scharphre, [REDACTED] did not have his backpack and asked Mr. Silberberg if he had it. Mr. Silberberg told her that it was with his mother, and then he entered his vehicle and left the school campus. Ms. Scharphre advised that Mr. Silberberg was driving a small white SUV, possibly a Nissan or Toyota, but she wasn't sure.

On 03/01/2021 at approximately 1215 hrs, I contacted School Police Disptach to determine if the known suspect had any active warrants. I was advised there were no active warrants for the suspect.

On 03/01/2021 at approximately 1300 hrs, I was able to review video camera footage of the bus loop/ drop off area for the morning of 03/01/2021 at [REDACTED] I viewed the video and at approximately 0823 hrs, I observed a mid-size white SUV pull up by the sidewalk area of the bus loop drop off area. I observed Ms. Scharphre speaking to a W/M subject, who exited the vehicle. I also could see a W/M [REDACTED] student exit the vehicle without a backpack. based on the quality of the video, I was unable to see the tag on the suspect's vehicle or determine the make of the White SUV.

At approximately 1315 hrs, I had Ms. Scharphre come to my office to review the video. Ms. Scharphre confirmed that the SUV observed at approximately 0823 hrs on the video, was indeed the SUV driven by Mr. Silberberg. She also confirmed the W/M subject who exited the SUV was Aaron Silberberg and the [REDACTED] student exiting the SUV was [REDACTED]

Based upon the sworn written statement from Ms. Scharphre, the observed video footage of Aaron Silberberg dropping of his child in the bus loop area of [REDACTED] coupled with the copies of the three signed Injunction for Protection Orders, there is probable cause to believe that the known suspect, Aaron Silberberg, did unlawfully violate the original Temporary Injunction for Protection ordered and signed by Palm Beach County Judge Laura Laurie on February 9,2021, contrary to Florida Statute 741.31 (4) (A).
