The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did I observed the defendant driving a gray Chevrolet with FL tag 4204PL on the I-275. He was speeding, 80 miles per hour in a 55 mile per hour zone. He was unable to maintain his lane and kept drifting out of his lane over the lane lines. I conducted a traffic stop and made contact with the defendant who was int he driver's seat. Upon contact I could smell the odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. He admitted to drinking alcohol. He performed field sobriety exercises and showed impairment. Post arrest I advised him of implied consent and he understood and refused to provide a breath sample.

A check on NCIC/FCIC showed his license was suspended in October, 2019 for failure to pay traffic fines and notice was provided.
