The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: April 24, 2020, I, Officer Edward J. Prouty with the Florida Fish and Wildlife Conservation Commission, while on water patrol on the Alafia River in Riverview, in Hillsborough County observed the defendant, Aaron W. Johnson operating a 15' Ghenoo on the waters of the state without his proper navigation lights displayed(all around white light not displayed properly). During the vessel stop, I observed glassy, bloodshot eyes, slow speech, and detected an odor of an alcoholic beverage coming from his person. Mr. Johnson submitted to field sobriety tasks which he perform poorly on. I read Mr. Johnson Florida's Implied Consent, which he agreed to take. On his first sample, his BAC was .112 and his second sample was .108.
