The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a gray 2010 Mercedes 4-door (FL TAG #NZYB56) southbound on Albany Ave S, when he ran the stop sign in front of me at Platt St W. At no time did the vehicle stop or even slow down as it passed through the stop sign at approximately 25 MPH. During the traffic stop for the infraction, the defendant was identified via a CA DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, swaying, fumbling fingers, admitted to drinking beer prior to driving, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a display of 6/6 HGN and a refusal to participate in additional SFSEs. While at CBT, the defendant was read Implied Consent and provided 2 valid breath samples, measuring .087/.087 BrAC.
