The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant was driving a silver 2009 Hyundai (FL TAG #IQNS46) northbound on Howard Av N in the right lane, drifting over the lane marker several times and struck the curb twice, destroying her front passenger wheel & tire. She continued to drive northbound for several blocks and attempted to enter the I-275 onramp, however her vehicle was unable to turn due to the accident. During a traffic stop for her suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, poor coordination, moved with slow/deliberate movements, admitted to drinking "1 drink" prior to driving and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a refusal to participate in SFSEs. While at CBT, the defendant was read Implied Consent and refused to provide a breath sample upon request.
