On 05/30/2020 at 0251 hours I conducted a traffic stop on a red 2019 Jeep Cherokee SUV, FL tag KAGP59 after I observed the vehicle driving the wrong way on a one way street, south bound on Howard Av N at Gray St W. Howard Av N is a north bound only at this point. Upon contact with the driver of the vehicle, defendant Abigale Gonzalez, I observed that she had bloodshot glassy eye and appeared very confused. Then as I instructed her to put her vehicle in Park I detected a very strong and distinct odor of an alcoholic beverage and vomit. I then further observed that there was vomit on the driver side door and the center console area. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0308 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .201/.211. I identified the defendant with a valid FL DL. She was the only one in the vehicle.
