The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/02/2019, at approximately 0148 hours, at Independence Pw / George Rd, Tampa, FL 33613, I conducted a traffic stop on a 2019 white Mercedes AMG (FL Z46CTL / VIN: 55SWF6EB0KU288367) after I observed the vehicle accelerating and decelerating multiple times, weaving within its lane of travel, crossing the outside white fog line multiple times, and under the suspicion of the driver being ill, tired or impaired. Upon making contact with the driver, I observed him to have bloodshot watery eyes, the severe odor of an alcoholic beverage on his breath, and slurred speech. Field sobriety exercises were conducted, further impairment was observed and the driver was subsequently arrested for DUI. Without provocation, the defendant admitted multiple times of having a few drinks tonight and taking anxiety medication. The Implied Consent Warning was read to the defendant at CBT, where he understood and when asked if he would provide breath samples, he stated, "No sir." The defendant was positively identified via his Florida driver's license.
