The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 15 day of APRIL, 2019,

at approximately 3:43 AM, at 9TH AVE N / 25TH ST N, in Pinellas County did:

UNLAWFULLY HAVE IN (HIS) ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, TO WIT: (POWDER COCAINE WEIGHING LESS THAN ONE GRAM) A PRESUMPTIVE TEST WAS POSITIVE.

THE DEFENDANT REMOVED A SMALL PLASTIC BAGGIE FROM HIS FRONT LEFT SHORTS POCKET AND DROPPED IT ON THE GROUND WHILE TALKING WITH POLICE DURING A CASUAL CONTACT. THE BAGGIE CONTAINED A WHITE POWDERY SUBSTANCE THAT FIELD TEST POSITIVE FOR COCAINE. SEARCH INCIDENT TO ARREST REVEALED THAT THE DEFENDANT HAD ANOTHER SMALL PLASTIC BAGGIE IN HIS REAR LEFT POCKET THAT CONTAINED POWDER COCAINE. POST MIRANDA WARNING, THE DEFENDANT ADVISED THAT THE BAGGIES CONTAINED HIS COCAINE, AND THAT HE SNORTS IT BY ROLLING UP DOLLAR BILLS. HE SAID THAT HE PAID \$50.00 FOR EACH BAG, AS THEY ORIGINALLY CONTAINED ONE GRAM EACH.

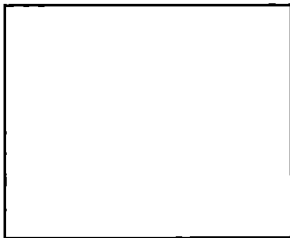
