The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 3/14/2021 hours, at approximately 0457 hours, Affiant observed a silver Kia bearing FL tag IRUF36 (VIN:KNAE25LA5J6035355) traveling northbound on Dale Mabry Hw N. The silver Kia was observed being operated without any lights activated after sunset and before sunrise. Affiant conducted a traffic stop on the vehicle at Dale Mabry Hw N / Floyd Rd in Tampa, FL and observed the defendant operating the vehicle. Affiant detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, his eyes were bloodshot and glassy, and he was slow in his movements when retrieving vehicle documentation. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). The defendant refused to provide a lawful sample of his breath to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of Central Breath Testing, he understood and replied "No." The defendant was identified via FL DL. The defendant was given a DUI citation A3T9QPE which reflects the DUI charge. The defendant also received Uniform Traffic Citation AEILQ4E for Operating Vehicle Without Lights After Sunset And Before Sunrise.
