The defendant was driving his 2019 Kia 4-door, bearing FL tag #QEIL28. Upon making contact with the defendant, he displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, fumbling with his documents, and an admission to consuming alcoholic beverages. The defendant exhibited clues of impairment and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .108/.107. The defendant identified himself via his FL driver's license.
