The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 12 day of JANUARY, 2020, at approximately 2:30 AM, at 21 3RD ST N, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: DISORDERLY INTOXICATION.

THE DEFENDANT WAS HIGHLY INTOXICATED, HAD A STRONG ODOR OF ALCOHOL COMING FROM HIS PERSON, BLOODSHOT WATERY EYES. THE DEFENDANT WAS REMOVED FROM A LOCAL ESTABLISHMENT (RUBY'S ELIXIR) BY SECURITY DUE TO BEING INTOXICATED AND CAUSING ISSUES WITH CITIZENS INSIDE.

THE DEFENDANT WAS OUTSIDE CAUSING A PUBLIC DISTURBANCE, HE WAS UNEASY ON HIS FEET. HE WAS STUMBLING INTO CITIZENS WALKING DOWN THE STREET. HE WAS BEING OBNOXIOUS AND DISTURBING CITIZENS TRYING TO EAT THEIR FOOD. HE SAT NEXT TO CITIZENS TALKING LOUDLY AND MAKING THE CITIZENS UNCOMFORTABLE. THE DEFENDANT'S BEHAVIOR WAS INITIATING A CONFRONTATION BETWEEN THE CITIZEN'S AND HIM. THE CITIZENS REQUESTED FOR HIM TO LEAVE THEIR TABLE.

THE DEFENDANT ENTERED A DIFFERENT ESTABLISHMENT CAUSING A DISTURBANCE BY SITTING NEXT TO A GROUP OF FEMALE CITIZENS. HE WAS HUGGING THEM AND LAYING HIS HEAD ON THEIR SHOULDERS. THE FEMALES APPEARED TO BE UNCOMFORTABLE. ONE OF THE FEMALE CITIZENS ADVISED US THAT THEY WERE EXTREMELY UNCOMFORTABLE WITH THE DEFENDANT AND WANTED HIM TO LEAVE.

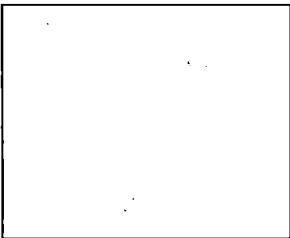
