| The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 10/20/2019, at approximately 0249 hours, I responded to the intersection of Balm Riverview Rd. and Boyette Rd. Riverview, FI. 33569 to assist Deputy Hibbard (ABN:252159) with a traffic stop. Deputy Hibbard conducted the traffic stop due to the vehicle failing to stop at a stop sign and failing to maintain a single lane. When Deputy Hibbard made contact with the defendant, who was the only person in the vehicle, she observed indicators of impairment. When I made contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. Post-Miranda, the defendant admitted to consuming four or five alcoholic beverages before operating the vehicle. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide lawful samples of his breath after a twenty minute observation.
