On the 11 day of September, 2021 at 22:03 (Specifically include facts constituting cause for arrest.) On 09/11/2021 at 2127 hours, I responded to 1116 Love St, Jupiter (Lucky Shuck), in reference to an unwanted guest who had been causing a disturbance at the restaurant. The male was reported walking westbound through the parking lot while wearing a blue shirt and camouflage shorts. Ofc. Bigtree and I then made contact with the male, later identified as Adam Persails (W/M DOB: 07/18/1978) as well as Lucky Shuck security guard, Keith Johnson (B/M DOB: 04/25/1994), and Lucky Shuck employee. Johnson provided a sworn statement of the following: While working as a security guard for Lucky Shuck, wearing a black security uniform shirt with Security badge embodied on the left upper chest area, he was advised of a subject wearing a blue shirt and camouflage shorts, later identified as Persails, smoking a cigarette on property. Johnson then approached the male and notified him that the entire property is a smoke free environment. Once informing Persails, he immediately refused to comply with the restaurants request. A short time later, Johnson was advised that the same male, was stumbling around while smoking a cigarette and approaching customers at their tables, causing them to feel uncomfortable. Persails then got involved in a verbal altercation with another customer and at that time, Johnson approached Persails and requested him to stop smoking once again. Due to Persails refusing to listen, he was requested to leave the establishment and began approaching Johnson while stating he refused to leave. In attempt to distance himself from Persails, Johnson lifted his hand, and Persails immediately swatted Johnson's hand out of the way and then put his face within close proximity of Johnson's. Johnson then began attempting to escort Persails off property, and at that time he pushed Johnson back and began screaming while calling him a "Nigger" 3 times in front of customers and fellow employees. After doing so, Persails began walking away. Johnson

advised he wished to pursue criminal charges of battery. I made contact with manager, Brendan Ohara (W/M DOB:11/21/1988), and Lucky Shuck employee, Nicholas Lanier (W/M DOB: 06/21/1988). Lanier provided a witness statement, advising that he observed Persails stumble and approach multiple tables while smoking a cigarette and making customers feel uncomfortable. Johnson then approached Persails, to which Persails became agitated. Johnson attempted to escort Persails out of the property, to which Persails swatted Johnson's hand and began screaming and called the Security guard "Nigger" 2 times. Ohara, provided me with security camera footage from the outside patio, which I observed Persails approach a table of customers. Shortly after, Persails is shown striking Johnson's hand out of the way. Ohara will be submitting all video to Evidence.com I then read Persails his miranda warnings from a preprinted miranda card. Post Miranda, Persails advised that his only involvement tonight was separating two parties from an altercation. Persails denied any other involvement. Based on the statements provided to me, Persails intoxication indicating an explanation for his erratic behavior, and video surveillance showing the above incident. I find probable cause to charge Adam Persails (W/M DOB: 07/18/1978) with Battery on a Uniformed Security Officer pursuant to F.S.S 784.07(2)(b), and Disorderly Intoxication pursuant to F.S.S 856.011(1). The above incident was captured on B.W.C. This report is a summary of the incident that took place and is not purported to be verbatim.
