The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 08/01/2021, at approximately 0339 hours, in the McDonald's drive thru located at 985 East Bloomingdale Ave, the defendant was the subject of a person down call for service. The complainant of the call stated the defendant was passed out in the driver seat of a white Ford F-150 (FL tag: GLDS20). Deputy C. Gibb (ABN 257675) observed the defendant to be passed out in the driver's seat of the vehicle. Deputy Gibb was able to wake up the defendant. Upon contact with the defendant, he had bloodshot glassy eyes, his speech was slow and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided two lawful samples of his breath, which resulted in a BrAC of .093/.087. The defendant was positively identified via his Florida driver license.
