The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On April 11, 2021, at approximately 0814 hours, Deputy M. Taylor arrived at the intersection of South Vlg Dr. and Southpark Dr., in reference to a Suspicious Vehicle call for service. The comments of the call advised that an unknown male was asleep in the driver's seat and that the driver was possibly intoxicated. Deputy Taylor observed a silver in color, four door Nissan Sentra bearing FL tag GTLZ39 within the intersection and blocking northbound traffic. He observed the defendant within the vehicle, the vehicle was running, and he detected multiple indicators of impairment of the defendant. The affiant responded to the scene and detected multiple indicators of impairment. The defendant refused to perform the SFSE's, and invoked is right to remain silent, at which he was subsequently arrested for DUI. Upon arrival to CBT, the defendant provided two lawful samples of his Breath Alcohol Content (BrAC), which yielded a 0.174 & a 0.175. The defendant was given a DUI citation (AA2R8EE), which reflects the DUI charge. The affiant positively identified the defendant via his FL DL.
