The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 02/22/2020, at approximately 0243 hours, at 7924 Hillsborough Av W, Tampa, FL 33615, Deputy Henry #255516 conducted a traffic stop on a 2019 dark green Toyota Highlander (FL tag: IBJH93 / VIN: 5TDZARFH0KS061287) for careless driving. Upon making contact with the driver, Deputy Henry observed him to have bloodshot watery eyes. The driver also provided a credit card when he was asked to show his driver's license. An empty bottle of Patron tequila was also observed in the rear driver's side passenger seat. Field sobriety exercises were conducted, further indicators of impairment were observed and the defendant was subsequently arrested for DUI. While at CBT, the defendant provided two breath samples, yielding results of .172/.162 BAC (after a twenty minute observation period). The defendant was positively identified via his Florida driver's license.
