The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On 08-20-2020 at approximately 0300 hours, I responded to the VIP slots locate at the Seminole Hard Rock Casino located at 5223 Orient Rd, Tampa FL in reference to a Domestic Battery.

Upon arrival contact was made with Security Supervisor Emma latimer, who stated a male later identified via his FL DL as, Ahmaed Gomez Jr, DOB 12-13-1981 advised her he was assaulted by his wife later identified via her Bolivian passport as, Adriana Udaeta, DOB 10-29-1982 While inside the VIP slot section.

Contact was made with Mr. Gomez Jr. who was very inebriated and argumentative, he stated Ms. Udaeta battered him while they were playing the slots over a phone call he made to her sister. Mr. Gomez Jr advised he wanted Ms. Udaeta arrested.

Contact was made with Ms. Udaeta, who stated she recently married Mr. Gomez Jr and today they came to have a good time at the casino and Mr. Gomez Jr began threatening her to call her sister only to aggravate her. Ms. Udaeta advised him if he call will upset her and they will argue. Ms. Udaeta stated Mr. Gomez Jr. called her sister and began antagonizing her to the point that she got upset at him and hit him several times as kept bothering her.

Review of the video showed Mr. Gomez Jr. showing the phone at Ms. Udaeta and making gestures at her and you observe Mr. Gomez Jr. passing the phone to her, I then observed Ms. Udaeta got upset walked behind Mr. Gomez Jr. and strike him on the back, you then observed Mr. Gomez Jr. laughing at Ms. Udaeta and walking towards her as he got close Ms. Udaeta hit Mr. Gomez Jr. in the chest as she backs away, you then observed Mr. Gomez Jr. walking towards Ms. Udaeta again and she hit him several more times as he smiles.

At that time with the information a received and what I observed on video Ms. Udaeta was placed under arrest for Domestic Battery and she was transported to the Orient Rd Jail for booking and processing.

Mr. Gomez Jr. and Ms. Udaeta had been married and living together for approximately 5 months and have no children in common.

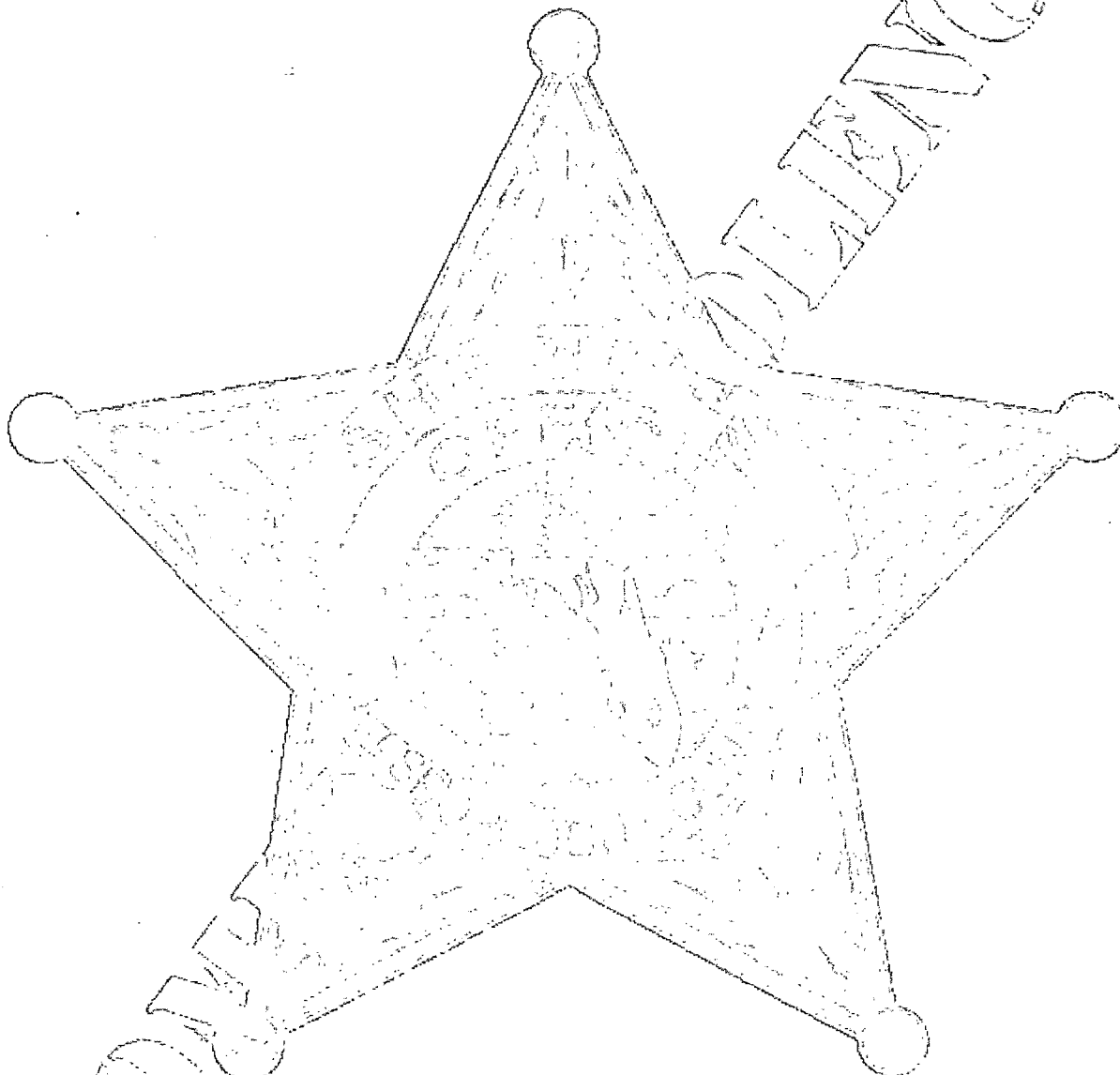
