On January 29, 2021, Yamilet Bolanos and another unknown male subject conducted a transaction with Associate Naranjo Cabezas in which she Passed- off \$1,476.27 by voiding the transaction and allowing the subjects to exit the store without paying for the merchandise.

On February 08, 2021, Yamilet Bolanos and Antonio Viera Barrio conducted a transaction with Associate Naranjo Cabezas in which she Passed-off \$2,096.27 by voiding the transaction and allowing the subjects to exit the store without paying for the merchandise.

On February 18, 2021, Yamilet Bolanos and Antonio Viera Barrio conducted a transaction with Associate Naranjo Cabezas in which she Passed-off \$410.04 by voiding the transaction and allowing the subjects to exit the store without paying for the merchandise.

On March 04, 2021, Yamilet Bolanos and Antonio Viera Barrio conducted a transaction with Associate Naranjo Cabezas in which she Passed-off \$1,128.16 by voiding the transaction and allowing the subjects to exit the store without paying for the merchandise.

According to the Home Depot loss prevention manager during their audit and investigation Naranjo Cabezas uses the same method of operandi every single time by entering the purchase merchandise and then voiding the transaction of some of the purchase items.

Based on the evidence presented on this date by Home Depot I found probable cause to arrest Ailen Naranjo Cabezas for Organized Scheme to Defraud.

Ailen Naranjo Cabezas was placed under arrest at the Home Depot manager's office and transported to Palm Springs Police Department.

Upon arrival I brought Naranjo Cabeza to the Criminal Investigations Unit interview room to conduct and interview.

Post-Miranda interview was conducted on video.

I asked Ailen Naranjo Cabezas the following general information, name date of birth, home address, phone number and other pertinent information. Naranjo Cabezas told me that she is Cuban national, and she came from Cuba (5) years ago, that she is currently working for Home Depot for the last (4) years as a cashier at the Pro-Desk which deals with commercial accounts.

I asked Naranjo Cabezas what happened to her today and she told me that she arrived at work at 07:00 hours for her shift that would have ended at 3:00 PM. She was fired following her being confronted by the store manager when she was informed about the allegations.

With the documents provided to me by Home Depot on this date with the allegations noted above. I began to show Naranjo Cabezas page by page of the transactions and photos of the suspects conducting the transactions on the above listed days. Naranjo Cabezas stated that she recognizes the subjects on the photos as Yamilet Bolanos and her husband Antonio Viera Barrio previously identified on her social media. I asked her how she knows Yamilet and Antonio. Naranjo Cabezas told me that Yamilet is her boyfriend aunt. She told me that one day she was talking to Yamilet and she had just bought a house and needed to make some repairs to the home, so they both came up with the idea of the scheme to defraud. During the interview Naranjo Cabezas admitted to every single fraudulent transaction listed on this report. The interview was completed, and Naranjo Cabezas was later transported to the Palm Beach County Jail.
