The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On May 4, 2020, the defendant was operating his silver Acura RL bearing Florida license plate#: JKFE11 (VIN: JH4KB16506C010996) on Fletcher Av. E. As the defendant pulled into the gas station located at 5601 Fletcher Av. E. he struck a stop sign, drove up an embankment, through bushes, and into the parking lot causing approximately \$700.00 in damages. The traffic collision was witnessed by Deputy J. Fulton ABN#: 257640. Deputy T. Jenkins ABN#: 254834 observed the defendant to be lethargic and laughing for no reason. Deputy B. Driscoll ABN#: 251509 observed the defendant to have dilated pupils, bloodshot and watery eyes, slurred speech, and he detected the odor of an alcoholic beverage emanating from the defendant's breath. I met with the defendant and observed him to have dilated pupils, slurred speech, bloodshot and watery eyes, and I detected the strong odor of an alcoholic beverage emanating from his breath. The defendant began standardized field sobriety exercises, but then refused to continue before beginning the walk and turn exercise. Once at Central Breath Testing, after being advised of the Implied Consent Warning and after a twenty-minute observation period, the defendant provided one breath sample of .139 and refused to provide any further lawful breath samples while being seated next to a ready instrument. I confirmed the defendant's identity via DAVID.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
