The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date, time, and location I responded to assist Dep. Heffron (ABN:250549) with a Traffic Crash. Dep. Heffron observed a black 1993 Nissan coupe bearing FL tag #KBIX48 (VIN:ECR33010184) strike the rear of another vehicle. Dep. Heffron observed the defendant sitting in the driver seat of this vehicle. Dep. Heffron made contact with the defendant and observed signs of impairment to include bloodshot watery eyes, unsteady on his feet, and the odor of an alcoholic beverage emitting from his breath. I made contact with the defendant and observed signs of impairment to include bloodshot watery eyes, slurred speech, unsteady on his feet, and the odor of an alcoholic beverage emitting from his breath. I explained to the defendant the traffic crash investigation was over and the DUI investigation is beginning. Post Miranda, the defendant admitted to drinking several alcoholic beverages. The defendant would not admit how many alcoholic beverages he consumed. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises the defendant showed signs of impairment. The defendant was subsequently arrested for DUI. The defendant agreed to provide a lawful breath sample (BAC .235/.233). The defendant was identified via Florida driver license.
