The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 10/16/2019, at approximately 0432 hours, near the intersection of Highway 301 South and I-75 North Ramp, Riverview; Florida 33578 the affiant observed the defendant operating a 2008 black Lexus IS 250 bearing Florida tag IMWZ62 with an assigned VIN of JTHBK262885069054 without a driver's side headlight. Upon contact with the defendant at the driver's side window, I observed indicators of impairment. Upon the defendant exiting the vehicle, I observed him to have bloodshot watery/glassy eyes, displaced motor skills, and I smelled the odor of an alcoholic beverage emitting from his breath. The defendant elected to participate in field sobriety exercise and upon doing so, he showed further indicators of impairment. Post Miranda, the defendant stated he had three glasses of wine earlier in the evening. The defendant was transported to Central Breath Testing and he provided two lawful breath samples of .069 and .068. I further identified the defendant via his DAVID photograph.
