On Saturday, May 16, 2020, at approximately 21:41 p. m., I responded to the area of N. Military Trail and Winchester Courts, Palm Beach Gardens, Palm Beach County, Florida, as a backup officer for Officer Smith, ID# 489. Refer to Officer Smith's supplemental report for further details regarding his contact with the vehicle. While at the scene, Officer Smith requested I assist with a possible D.U.I. Investigation.

Upon approach to the vehicle, I observed a white male, seated in the driver's seat. I identified myself as an officer with the Palm Beach Gardens Police Department and the male was identified via his Florida Driver's License as Alan Ross Barbee (12/08/1965).

OBSERVATION OF DRIVER:

While standing next to the window, I smell the odor of alcohol coming from within the truck. I asked Barbee to step out so I can speak to him to assert whether the odor was coming from him. Outside of the truck, I could smell the scent of an unknown alcoholic beverage emitting from Barbee's breath while at a conversational distance. I observed Barbee's pupils be dilated more than an average person, the sclera of his eyes to be reddened and watery.

DRIVER'S STATEMENTS:

Barbee stated that he was driving toward Jupiter to do a friend a favor. Barbee agreed to perform SFST's. At the Breath and Alcohol Testing Center, Barbee stated he drank approximately five drinks within the last 3 hours before the traffic stop. Barbee performed the tasks on a flat, dry surface that was well lit.

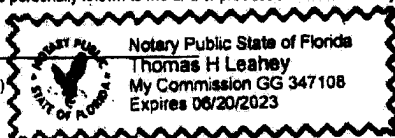

Other Observations:

I observed the sclera of his eyes to be reddened; his eyes to be watery; his face to be flushed, and his speech to be slurred. During this encounter, I noticed Barbee had an unsteady walk.

WALK & TURN:

I explained and demonstrated the instructions to Barbee, who stated he understood.

During the instruction stage, Barbee failed to maintain the position and stepped off-line, placing his feet apart. Barbee also started before instructed. During the first set of steps, Barbee missed heel-toe consistently, Barbee did not perform the turn as instructed, failing to take a small series of steps to turn; On the return set of steps, Barbee missed heel-to-toe again and stepped off line. Barbee did not counted out loud as instructed and demonstrated.

ONE LEG STAND:

I explained and demonstrated the instructions to Barbee, who stated he understood.

Barbee was having a difficult time standing up straight. Barbee was visually swaying and did not keep his legs straight, nor his foot parallel to the ground as instructed and demonstrated.

FINGER TO NOSE:

I explained and demonstrated the instructions to Barbee, who stated he understood. Barbee did not perform the task as instructed. He raised the appropriate finger, but he did not touch the tip of the finger to the tip of the nose as instructed and demonstrated.

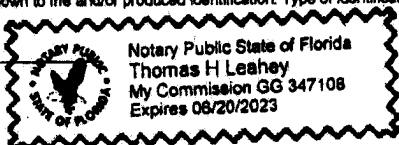

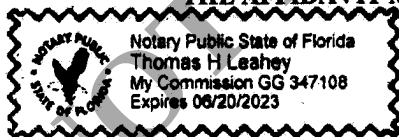

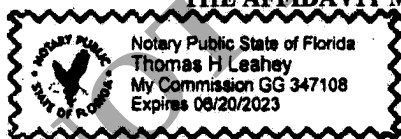
