The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 06/06/2021 at 0336 hours, Deputy Alejandro A. Correa responded to 32nd Av S / 78th St S about a person down inside a blue Ford F-150 (bearing Florida Tag: 11ABHM) passed out behind the wheel. Deputy Alejandro A. Correa was able to awake the driver (Alejandro Jodar Velazquez) and immediately noticed signs of impairment. Deputy Alejandro A. Correa then requested a DUI-Investigator for a possible impaired driver.

At the incident scene, I observed the vehicle mentioned above and Alejandro Jodar Velazquez (driver), assisted by the HCFR. Alejandro Jodar Velazquez refused EMS by saying "No." Additionally, I noticed multiple signs of impairment on Alejandro Jodar Velazquez, such as slurred speech, red glassy eyes, unbalance on his feet, and a strong odor of alcoholic beverage on his breath. Due to the totality of circumstances and multiple signs of impairment, I asked Alejandro Jodar Velazquez if he was willing to perform the Standardized Field Sobriety Exercises (SFSE's). Alejandro Jodar Velazquez agreed to perform the SFSE's. Alejandro Jodar Velazquez, I started with the Horizontal Gaze Nystagmus (HGN). Alejandro Jodar Velazquez was unable to perform the HGN as instructed and requested. I determined that Alejandro Jodar Velazquez's level of impairment was so high that he was unable to complete the SFSE's; I placed him under DUI arrest for his safety.

I transported Alejandro Jodar Velazquez to the HCSO Central Breath Test (CBT) section. After the mandatory uninterrupted twenty-minutes observation period ended, Alejandro Jodar Velazquez provided two lawful breath samples. Alejandro Jodar Velazquez's BAC .231 / .232 (DUI Citation: A0FQ4IE). Alejandro Jodar Velazquez was identified via his valid Florida # J361000820640.
