On the above date and time I responded to 5690 CINNAMON DR in unincorporated West Palm Beach FL 33415 in reference to a domestic. Upon my arrival I met with Alejandro Vargas who stated that he wanted us to get his children for him. I have been to the residence three times prior to this. The first time occurred at 00:20 hours PBSO case # 20031199, he had came home drunk and was verbally arguing with his wife he refused to speak with me. The wife left the residence with the minor children. I then responded again at 01:54 hours, Vargas wanted us to get his minor children. He was informed it was a civil matter and needed to go to court for any custody issues. The third time occurred at 02:02 hours when Vargas stated that he wants his children home and he will continue to call 911 until we get his children. He also stated to dispatchers that "COMPLAINANT ADVISED HE DOESNT CARE IF HE GETS ARRESTED FOR REPEATEDLY CALLING 911" and "COMPLAINANT REQUIRES CONTACT ADVISED HE WILL KEEP CALLING 911 IF HE HAS TOO" Each time he was advised this was a civil matter and to stop calling 911 unless there was a true emergency or that he could call the non emergency number. Due to the above I find Vargas in violation of F.S.S 365.172(1) MISUSE OF 911 OR E911 SYSTEM. Service must be used solely for emergency communications by the public. Any person who accesses the number 911 for the purpose of making a false alarm or complaint or reporting false information that could result in the emergency response of any public safety agency, any person who knowingly uses or attempts to use such service for a purpose other than obtaining public safety assistance, commits a misdemeanor in the first degree.
