The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 02/07/2020, at approximately 2321 hours, the defendant was the subject of a reckless driver call for service, while driving a red Hyundai Elantra, bearing Florida tag HVMX96, with an assigned VIN of KMHDN45D22U330848. Corporal B. Dobson (ABN 4809) was in an off duty capacity while driving his personal vehicle, when he observed the Hyundai Elantra traveling in front of his vehicle. Corporal Dobson observed this vehicle weave out of it's travel lane (approximately 20 times), drive off the roadway and almost get into an accident with a truck on the interstate. Deputy T. Adams (ABN 252862) made contact with this vehicle at the intersection of Walker Rd and East Fowler Ave. Upon contact with the defendant, she had bloodshot glassy eyes, slurred speech, unsteady balance and the distinct odor of an alcoholic beverage emitted from his breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant then provided a lawful sample of her breath resulting in a BAC of .161/.159. The defendant was identified via her valid Florida driver's license.
