The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was stopped after he made an improper left turn from the right lane, he was weaving in and out of his lane, and he violated a red light when turning right. The defendant was driving a 2019 Toyota Camry, bearing FL tag #IEMR70. Upon making contact with the defendant, he displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, and unsteady on his feet. The defendant exhibited several indicators of impairment during the SFSEs, and was arrested for DUI. A search of the defendant incident to his arrest, revealed his wallet in his back right pants pocket. Inside the wallet, the affiant found a small plastic jewel baggie containing about a gram of a white powdery substance. The substance had the appearance of powder cocaine, and field tested positive for cocaine. The defendant later submitted to the breath test, which had a BrAC of .207/.211. The defendant identified himself via his CT driver's license. Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge.
