Defendant was administered a series of SFST's which she was unable to perform satisfactorily. Post Miranda the defendant admitted consuming approximately 5 mixed drinks within a 2 hour period before driving. Defendant was arrested for DUI and was transported to CBT where she was administered a breath test. Defendant's BrAC measured .163 / .156. This occurred in Hillsborough County, Florida.
