The eyewitness stated the defendant was driving his gray Nissan Xterra bearing FL(5414QM) northbound on Florida Av N at a high rate of speed before it swerved and struck four unoccupied vehicles parked on the west side of Florida Av N. The Xterra continued northbound on Florida Av N where it knocked down a No Parking traffic sign and came to rest against a black BMW sedan parked on the north side of Harrison St E. The crash caused an estimated \$25000 in damages. During observations the defendant, Alexander Benjamin Reistra displayed multiple indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on his breath. During SFST's he displayed additional indicators of impairment and was arrested for DUI. The defendant was taken to CBT where he took the breath test. He provided breath samples of .154/.160. The defendant's identity was verified using his Florida drivers license.
