The defendant was stopped by Officer R. Williams for speeding, weaving in and out of his lane, and running off the roadway multiple times while driving east on Melburne Blvd from 40th St N. The defendant was driving a rental U-Haul pick-up, bearing AZ tag #AK08289. Upon making contact with the defendant, he displayed several signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, slurred speech, dozing off while seated in his vehicle during the stop, possession of open beer containers, unsteady on his feet, swaying as he stood, and repeated spontaneous admissions to being drunk. The defendant could not complete the SFSEs, spontaneously admitting he was too drunk to continue. The defendant was arrested for DUI, and later submitted to the breath test, which had a BrAC of .227/.207.

The defendant identified himself via his FL driver's license.
