Approximately three minutes later while still on scene at the above address, dispatch advised Gray called in on 911 (approx. 2305 hours) requesting a Sergeant. Gray was advised a Sergeant would return his call on an administrative line. At approximately 2307 hours, Gray called back on 911 again, stating that he was just trespassed from Castaways and was demanding a Sergeant. He advised dispatch that he was just off the property and the Sergeant knows who he is. Gray was again advised he could leave a message or meet a sergeant at the Jupiter Police Department if he wished to file a complaint and advised not to use 911 for this issue. At approximately 2314 hours, Gray called 911 again demanding a sergeant to file complaints on officers. Dispatch advised him yet again, that he could not call 911 to file a complaint. Contact was made with Gray standing in front of 960 S. A1A. I asked Gray if there was an emergent circumstance that he continued to call 911 for, and he advised there was not. Due to being warned approximately four separate times of the proper use of 911 and that his complaint was a misuse of 911, Gray was placed under arrest. Gray is being charged with misuse of 911 pursuant to F.S.S. 365.172(11).

Gray was transported back to the Jupiter Police Department for booking procedures. While en-route to the police department, Gray stated that he hopes that my wife and my daughter get spit on and raped. Gray was ultimately transported and turned over to the Palm Beach County Jail. BWC used.
