#### **NARRATIVE:**

On 04/26/2021, Your Affiant assumed investigative lead for an aggravated assault with a deadly weapon case that occurred on 04/25/2021 at 'Bryant Park' located at 100 South Golfview Road, Lake Worth Beach, FL. After reviewing the log entry and CAD report, Your Affiant spoke with complainant/victim Adam Pantelakos, herein after Pantelakos, and obtained a sworn taped statement. The following is a summary of the interview: The evening (2030hrs) of 04/25/2021 he and his wife, Ashley Andrews were fishing in 'Bryant Park' near the boat docks. As a boat came in (to trailer), their lines (fishing) got wrapped up in his boat and they made him (driver of the boat) aware to which the man yelled profanities at them. Pantelakos cut the fishing line to Andrews' reel and he continued to fish.

The driver of the boat hooked up his boat then drove next to the dumpsters, approximately thirty-yards from where they were sitting by the seawall. Pantelakos observed the man exit his truck and approach them ". . . with a stick or a billie club or a fishing club". Pantelakos said the man was waving the club at his wife as yelled profanities at them both. Concerned for his wife's safety, Pantelakos stepped between the man and his wife and told him he needed to leave. The man then struck Pantelakos in the head with the billie club causing a deep laceration to the left side of his forehead. Pantelakos responded, "Is that all you got" and the two men engaged in a physical scrum lasting seconds. The man then ran back to his vehicle yelling at his wife to get inside. Pantelakos ran after him, observing the white and black twin-engine outboard boat and truck with an attached 'Seminole' tag. Pantelakos did provide Florida license plate number WY815 and vehicle description of a red GMC truck towing a boat to PBSO Dispatch.

Your Affiant asked Pantelakos if the male said anything specific to him. He replied the man just kept cursing and screaming about his boat. He could discern if he was under the influence of alcohol, but due to his response being "... over the top and out of line" he assumed he was intoxicated. Your Affiant asked him to describe the weapon Pantelakos stated it

is a fishing club and his was a "... long wooden stick that he brought with him". These 'billie clubs' are used to kill larger fish when brought onboard after catch.

Pantelakos described the suspect as a white male, older than him, with grayish or black hair, approximately 5'7 (suspect was standing on seawall), clean shaven and no visible tattoos. EMS treated Pantelakos' head injury on scene. He provided PBSO responding Deputy Sheriff Kobitka #37078 a written statement prior to leaving for his residence. On 04/26/2021, Pantelakos realized the laceration to his forehead was deeper than he thought so he had to seek medical treatment at an Urgent Care facility. Once seen by a physician he received two staples and a prescription for antibiotics.

For complete details, regarding information learned during the interview, please refer to file titled 'Adam Pantelakos Interview'. Your Affiant submitted a copy of the interview to PBSO Evidence.

Your Affiant detailed the timeline of events, to include CCTV still photographs of the events that occurred on 04/2/2021 at Bryant Park. One camera captured the events at Bryant Park.

8:21 – The suspect's boat is observed pulling into the boat ramp and a person is observed exiting onto the dock then walking south into the parking lot.

8:23:57 – A maroon truck pulled around and backed down boat ramp to attach vessel.

8:28:47 – The driver, later identified as Alexander J Terribile, WM, 02/24/1970 pulled truck with boat, white hull with dark colored stripe, center console with twin-engines, next to dumpsters approximately 75' from ramp and seawall.



8:28:50 - Terribile exited truck and goes to hitch ensuring boat was properly attached to trailer

8:28:57 - Driver's wife, later identified as Leslie Terribile, WF, 11/04/1972 walked up to rear of boat

8:29:25 - Terribile suddenly turned around and quickly walked to rear of boat where his wife was standing


8:30:44 - Terribile is observed at the left rear of the boat trailer.

8:31:06 – Terribile is observed at the right rear of the boat trailer and appeared to be looking at the motor propeller.


8:32:15 – Terribile's wife walked to the passenger side of truck as he continued to check the engines.




8:32:41 – Wife walked to the back of the boat – standing off to the side

8:33:01 - Terrible walked along the seawall to where Pantelakos and his wife were fishing











The last series of still photograph provided to show Terribile's quick exit from the City of Lake Worth Beach. Terribile left Bryant Park boat ramp at 8:34:41PM. He exited the City of Lake Worth Beach at 8:39:26PM. It took him less than five minutes, 4 minutes and forty-five seconds, to travel approximately 1.88 miles through traffic.

Your Affiant conducted a scan of license plates using the 'License Plate Reader (LPR) System' at 10<sup>th</sup> Avenue North on 04/25/2021 between 8:38PM to 8:40PM and obtained the suspect's – Terribile's – Florida State University 'Seminole' license plate 'WY81F' along with a photograph of his truck towing his boat at 8:39PM.



According to DAVID, Terribile purchased this General Motors Company (GMC) truck on or about 03/02/2020 with approximately 10 miles on the odometer. He is the only registered owner.

On 04/27/2021, Your Affiant created a black and white photo lineup using the 'Intellitech' software program and Terribile's Florida driver's license picture from 01/22/2020. Terribile's photograph was placed in position number (3) with five similarly featured white males in the remaining locations. The lineup was printed in black and white and placed inside a PBSO photo lineup instruction pamphlet.

On 04/29/2021 at 1238hrs, Det. B. Garcia #18167 met with Pantelakos at PBSO District 14 substation to present him the photo Lineup. Det. Garcia tape-recorded the session that Your Affiant later submitted to PBSO Evidence. The following is a synopsis of their meeting: Det. Garcia swore Pantelakos in then read the instructions aloud to Pantelakos, who signed to each line confirming his understanding. Det. Garcia then left Pantelakos alone to review the series of photographs. After several minutes, Pantelakos initialed and dated the male in position number four (4). It must be noted; the male in position number four does resemble Terribile having similar length of hair, eyebrow shape, drooping eyelids, and pointed/thick chin. Moreover, after the photo lineup presentation was completed, and Det. B. Garcia left the area, Pantelakos told Your Affiant it was very dark on the seawall so he did not get a great view of the suspect.

On 04/29/2021, Your Affiant obtained copies of Pantelakos and Andrews written statements provided to DS Kobitka. Review of Pantelakos sworn statement is consistent with his verbal statement. Moreover, on the bottom Pantelakos wrote "Partial plate Seminole \_ \_ 851?? Possibly" which matches the 'Seminole' plate and number '8'. Your Affiant reviewed Ashley Andrews' sworn written statement, which reads, in summary: She and Pantelakos were fishing when a boat approached the docks. As the driver neared, her husbands fishing line wrapped into the boater's engine. Both of them yelled to the boat driver that their fishing line may have been 'run over' to which the male driver yelled obscenities back.

After the two people on the boat got it trailered, the man approached them holding a bat in his hand. He yelled that their fishing line is tangled in his boats lower unit (propeller) to which they replied they tried to tell him and he began swinging the bat at her. Her husband stepped in between her and the man and told him to leave. She pulled her phone out to call '911' and the man struck her husband in the head. She heard the man's wife yell at him and he turned and ran to his truck.

On 05/04/2021 at 1000hrs, I spoke with Ashley Andrews concerning this case. Andrews also advised Your Affiant the street light (in the parking lot) is not very bright, but she would review a series of photographs in attempt to identify the suspect.

On Sunday, May 10<sup>th</sup>, 2021 at approximately 1250hrs, Ashley Andrews met with Deputy Sheriff Phipps #33643 at District 14. DS Phipps conducted an audio/video taped photo lineup presentation with Andrews. After reading the instructions from the lineup instruction pamphlet, DS Phipps walked away leaving Andrews to review the photographs. Andrews reviewed the pictures for approximately thirty-seconds asked DS Phipps something about identification. DS Phipps referred advised her to refer back to the instruction pamphlet and told her if she can make a positive identification then okay, but not to feel like she has to. Andrews circled the male in position number six (6) which is Alexander J. Terribile. Please refer to DS Phipps audio/video file for complete details.

Based on the aforementioned case facts, Your Affiant finds probable cause to charge Alexander J Terribile, WM, 02/24/1970 with one (1) count 'Aggravated Battery with Deadly Weapon' per F.S. S. 784.045(1)(a)(2) to wit: did actually and intentionally touch or strike Adam Pantelakos against the will of Adam Pantelakos, and in doing so used a 'Billy Club/Bat, a deadly weapon, contrary to Florida Statute 784.045(1)(a)2 and (2).
