The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a silver 2019 Mazda (FL TAG #EKQJ35) westbound on Platt St W, which is a one-way street with eastbound traffic only.
