On 02/07/2020 at approximately 0112 hours, I responded to 599 Hastings Street to assist Officer Galazka with a traffic stop.									
P R O B A B L E	Upon my arrival, Ofc. Galazka brought it to my attention that he initiated a traffic stop on a white Ford Mustang bearing FL tag KMED63. Ofc. Galazka mentioned he observed the vehicle originally at the intersection of N Federal Highway and NE 40th Street. The vehicle was heading northbound on N Federal Highway (within the far right lane) when he observed the vehicle swerve in and out of the bicycle lane and driving lane several times. Ofc. Galazka noticed the vehicle's left side tag-light out, and he initiated the traffic stop (citations issued and submitted into evidence). Ofc. Galazka made contact with a W/F Alexandra Turturo (DOB: 11/14/1989) who was operating the white Ford Mustang. Ofc. Galazka noticed Turturo's eyes were glossy and red. Turturo was also slurring her words when she was speaking. That is when I showed up and took over the investigation.								
	I asked Turturo where she was headed, she responded with "home". Turturo mentioned she just got off work, (she works at Trattoria Romano and dog sits). When I asked, Turturo mentioned she did not have anything to drink that night. While I was speaking with Turturo, she was confused with some of my questions and was slurring her words. I asked Turturo if she would be willing to consent to some field sobriety tasks, which she stated she would. Turturo stated she was not on any medications and she did not have any injuries.								
S T A T E M E N T	The first task was the walk and turn. I explained and demonstrated the task to Turturo and she stated she understood the instructions. Turturo needed me to reread a portion of the instructions to her before she began the task. Turturo began the task and she failed to take any heel to toe steps. Turturo used her arms for balance and she did not count her steps out loud the entire time. Turturo failed to stay on the yellow line painted on the floor.

The second task was the one leg stand. I explained and demonstrated the task to Turturo and she stated she understood the instructions. While performing the task Turturo stated "1005" two times in a row and "1006" two times in a row. She could not hold her foot up and she was off balance. Turturo was using her arms for balance throughout the whole task. Turturo stopped counting at "1010" and finished the task on her own terms. The third task was the finger to nose, (It should be noted that the task was left, right, left, right, right, left). I explained and demonstrated the task to Turturo, which she stated she understood. While performing the task Turturo was swaying and her feet were not together, like instructed to do so. Turturo did not keep her head back the full time of the task. The fifth task was the Rhomberg Alphabet. Turturo mentioned she was familiar with the English Alphabet. I explained and demonstrated the instructions and Turturo mentioned she understood. During the task Turturo was swaying while reciting the English Alphabet. Turturo did not keep her arms by her side and her head was not back. While reciting the alphabet, Turturo stopped at G and started to sing the alphabet to herself. She did not pick the alphabet back up. At this point, I placed Turturo under arrest for the violation of the Florida State Statute 316.193(1) driving under the influence. Turturo was placed in handcuffs. Turturo was transported to Boca Raton Police Department to be processed. Officer Ricciardi responded to BRPD to be the Breath Technician (supplement added). While conducting the breath analysis portion of my investigation, I asked Turturo to provide a legal sample of her breath, to which she refused. I read her implied consent and again she refused at 0216 hours. Turturo advised that she wanted to talk to an attorney. I then read Turturo her constitutional warnings from the BRPD issued form, to which she advised she did not want to speak with me. Turturo was then transported to Palm Beach County Jail.

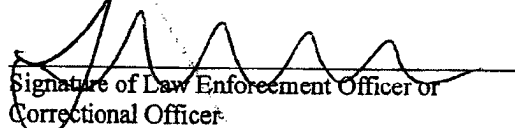

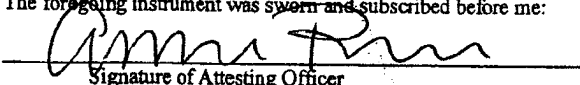

JUVENILE CONSTITUTIONAL WARNINGS

Rights of suspects prior to custodial questioning.

Identify yourself and state:

I am required to warn you before you make any statement that you have the following Constitutional rights:

- (1) You have the right to remain silent and not answer any questions. *Tell me in your own words what you think this means.*
(You do not have to talk to me or answer any questions about this offense. You can be quiet if you want.)
- (2) Any statement you make must be freely and voluntarily given. *Tell me in your own words what you think this means.*
(If you do talk to me it has to be because you want to and not because anyone is forcing you to speak.)
- (3) You have a right to the presence and representation of a lawyer of your choice before you make any statement and during any questioning. *Tell me in your own words what you think this means.*
(You can talk to a lawyer before we ask you any questions and you can have him/her with you now, during our questioning.)
- (4) If you cannot afford a lawyer, you are entitled to the presence and representation of a court appointed lawyer before you make any statement and during any questioning. *Tell me in your own words what you think this means*
(If you do not have money for a lawyer and you want one, a lawyer will be given to you for free.)
- (5) If at any time during the interview you do not wish to answer any questions, you are privileged to remain silent. *Tell me in your own words what you think this means.*
(If you decide to talk to me then change your mind, you can stop answering my questions at any time.)
- (6) I can make no threats or promises to induce you to make a statement. This must be of your own free will. *Tell me in your own words what you think this means*
(I am not allowed to threaten you or make you any promises to get you to talk to me. If you decide to talk, it must be because you want to.)
- (7) Any statement can be and will be used against you in a court of law. *Tell me in your own words what you think this means*
(Anything you say to me can and will be told to the judge or a jury in court. A judge is a person who decides if you have done something wrong. Sometimes a group of people called a jury decide this, but the Judge is the person who decides what punishment you get.)
- (8) Do you understand these rights as I have read them to you, and do you wish to speak to me?
