The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 10/20/2019 at 2307 hours I responded to Sligh Av W just east of 12th St N after Tampa Police Officer Evan Desimone (52090) conducted a traffic stop on a red 2019 Toyota sedan, FL tag NBLH54 after he observed that the front right tire of the vehicle was missing and that the vehicle was driving on the rim with sparks flying everywhere. Upon contact with the driver of the vehicle, defendant Voulgarakis Officer Desimone observed signs of impairment. Suspecting that the defendant was impaired Officer Desimone requested a DUI unit. Upon my arrival I made contact with the defendant and immediately observed that she had extremely bloodshot glassy eyes and then as I explained to her who I was and why I was there I detected a distinct odor of an alcoholic beverage. Post Miranda the defendant then admitted to drinking "one tequila drink and one rum drink " at the Bahama Breeze on the Courtney Campbell Causeway where she works. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 2326 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .195/.184. I identified the defendant with a valid FL DL.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
