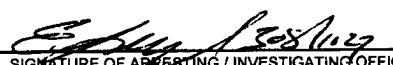

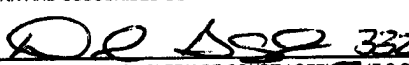
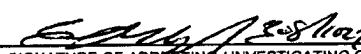

On 11-04-2020 at 1925 hrs., I responded to a reported suspicious incident that occurred at Aces High Tattoo, 601 W. Indiantown Rd #5, Jupiter, FL. The caller, Taylor Roberts (w/m 11-16-96) reported his girlfriend, later identified as Katherine M. Sullivan (w/f 02-01-2000) had been sexually assaulted by a tattoo artist. The caller said they would meet us at Green Turtle Plaza, 2562 W. Indiantown Rd, Jupiter. Upon my arrival, I spoke to Sullivan, who was very upset and crying. She said she went to Aces High for a 5:00 PM tattoo appointment with Alexandre L. Moretti (w/m 10-04-79). She said it was her second appointment with him to work on a tattoo on her left thigh. She said he was holding onto the inside of her thigh, which she understood was normal. Sullivan said as he continued tattooing the flowers (which is top/slightly inside thigh), his hand went further up her thigh until he was touching her crotch (vagina) seperated by her bikini bottom. She said his entire hand was on her crotch and he started moving his fingers (slowly and subtly). She said at first she was trying to figure out if it was innocent and as it continued, she felt that it was wrong. Sullivan said she texted her boyfriend because she was so uncomfortable. She showed me the text which was at 7:03 PM and said that she thought the tattoo artist was feeling her up. She said when Moretti started working on the other section of the tattoo (which is more to the outside of her thigh) his other hand was still by her crotch and he was trying to pull back her bottoms (she was wearing bikini bottoms). She said his fingers went under her bikini bottom and he got them "into the slit" (inside labia). Sullivan said she yelled (Sorry, can you stop fucking doing that! I've been trying to figure out for the past half hour if you've been feeling me up) at him and she jumped back in the seat to get away from him. She said if she didn't stop him she believed he would have penetrated her. She said after she yelled at him, he said he was sorry and he wanted to talk to her outside so he could explain himself. She said she stepped over to the door with him. She said he apologized again and that he didn't know what came over him. She said Moretti said he was stretching her and when he saw it he couldn't help himself. She said she just wanted to pay him and leave, but he wouldn't accept her payment.

She said she threw the money at him and he gave it back to her. Sullivan said there was another female being tattooed by another artist in the same booth, but she didn't know what she saw. At 2049 hrs., I arrived at Aces High and was informed that Moretti had left already. Another employee called him and asked him to return to the store. I spoke to the other artist, who said his back was to them and he was focused on tattooing his client so he didn't see anything. I spoke with the client, Sydney K. Reece (w/f 11-01-96) who said she didn't really see anything, but the girl (Sullivan) was getting tattooed in a sensitive area and she freaked out. She said Moretti (who she doesn't know) looked really scared afterwards and said he didn't do anything. I asked her if she could see how he was holding her leg and Reece said she couldn't see. Reece said Sullivan jumped really quick and she was angry. She said Sullivan tried to pay him and Moretti said he wasn't going to take her money, so she took it back and left. At 2116 hrs., Moretti arrived back at the shop. I read him Miranda Warnings and he said he would speak to me. I asked him to tell me what happened with the girl he was tattooing before. He said he tattoos like that all the time and sometimes you have to stretch and it's accidental, the tattoo is right there. He said all of a sudden she said stop, dude you've been trying to feel me in for and he couldn't remember how long she said. He said he asked her to talk to him because he was freaked out. He said he talked to her outside and she didn't want to talk. He said he apologized for anything, he said maybe because she is 18 years old and getting a tattoo like that, then said he didn't know. He said she took out the money for 2 hours, but he was freaked out and she got the money back. I asked him to clarify what he meant when he said about it being a mistake before. Moretti said "it happens" and then showed me grabbing his thigh and said, "I have to grab here and it touches, that's what happens, the tattoo is right there". Moretti denied going under her bottoms. Based upon my above described investigation, I find probable cause does exist to charge Alexandre L. Moretti with Simple Battery, as he did actually and intentionally touch or strike Katherine M. Sullivan against the will of Sullivan (or) did intentionally cause bodily harm to Sullivan, pursuant to F.S.S. 784.03(1). (1 DEG MISD) I placed Moretti in handcuffs, which were double locked and checked for proper spacing. I transported him to the Jupiter Police Department for processing then to the Palm Beach County Jail.

She said if she didn't stop him she believed he would have penetrated her. She said after she yelled at him, he said he was sorry and he wanted to talk to her outside so he could explain himself. She said she stepped over to the door with him. She said he apologized again and that he didn't know what came over him. She said Moretti said he was stretching her and when he saw it he couldn't help himself. She said she just wanted to pay him and leave, but he wouldn't accept her payment. She said she threw the money at him and he gave it back to her. Sullivan said there was another female being tattooed by another artist in the same booth, but she didn't know what she saw.

At 2049 hrs., I arrived at Aces High and was informed that Moretti had left already. Another employee called him and asked him to return to the store. I spoke to the other artist, who said his back was to them and he was focused on tattooing his client so he didn't see anything. I spoke with the client, Sydney K. Reece (w/f 11-01-96) who said she didn't really see anything, but the girl (Sullivan) was getting tattooed in a sensitive area and she freaked out. She said Moretti (who she doesn't know) looked really scared afterwards and said he didn't do anything. I asked her if she could see how he was holding her leg and Reece said she couldn't see. Reece said Sullivan jumped really quick and she was angry. She said Sullivan tried to pay him and Moretti said he wasn't going to take her money, so she took it back and left.

At 2116 hrs., Moretti arrived back at the shop. I read him Miranda Warnings and he said he would speak to me. I asked him to tell me what happened with the girl he was tattooing before. He said he tattoos like that all the time and sometimes you have to stretch and it's accidental, the tattoo is right there. He said all of a sudden she said stop, dude you've been trying to feel me in for and he couldn't remember how long she said. He said he asked her to talk to him because he was freaked out. He said he talked to her outside and she didn't want to talk. He said he apologized for anything, he said maybe because she is 18 years old and getting a tattoo like that, then said he didn't know. He said she took out the money for 2 hours, but he was freaked out and she got the money back. I asked him to clarify what he meant when he said about it being a mistake before. Moretti said it happens and then showed me grabbing his thigh and said I have to grab here and it touches, that's what happens, the tattoo is right there. Moretti denied going under her bottoms.

Based upon my above described investigation, I find probable cause does exist to charge Alexandre L. Moretti with Simple Battery, as he did actually and intentionally touch or strike Katherine M. Sullivan against the will of Sullivan {or} did intentionally cause bodily harm to Sullivan, pursuant to F.S.S. 784.03(1). (1 DEG MISD)

I placed Moretti in handcuffs, which were double locked and checked for proper spacing. I transported him to
