The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant was driving a gray 2015 Toyota 4-door (FL TAG #EZIT94) southbound on Nebraska Av N, when she was observed by officers to drift in and out of her lane, make erratic lane changes, random stopping/accelerating, and ran a stop sign. During the traffic stop for the infraction and suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, slow/deliberate movements, short-term memory loss, confusion/disorientation, was in possession of marijuana, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she provided 2 valid breath samples, measuring .198/.191 BrAC.
