The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date, time, and location I observed a white Kia SUV bearing FL tag #DRSU48 (VIN:KNDEU2AA6M7055160) traveling westbound on Brandon Bl./ St. Cloud Av. I observed this vehicle strike the median while traveling in the inside lane. I conducted a U-turn at St. Cloud Av. and caught up to this vehicle. This vehicle failed to come to a full and complete stop for the steady red light for the left hand turn. I observed this vehicle make a left turn onto Miller Rd. from Brandon Bl. I observed this vehicle fail to maintain a single lane traveling south on Miller Rd. I activated my emergency light to conduct a traffic stop. I made contact on the passenger side of this vehicle. I observed the defendant in the driver seat of this vehicle, with a passenger in the front seat. I observed signs of impairment to include bloodshot watery eyes, slurred speech, and the odor of an alcoholic beverage emitting from this vehicle. I requested the defendant exit this vehicle to speak with me, which she agreed. The defendant lost her balance exiting this vehicle and had to lean on the vehicle to regain her balance. While speaking with the defendant I could observe the odor of an alcoholic beverage emitting from her breath. Post Miranda, the defendant did not admit to consuming any alcoholic beverages. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises. She was arrested for DUI based on the totality of the circumstances. The defendant was read Implied Consent, and she refused to provide a breath sample. The defendant was identified via Florida driver license.
