The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a black 2018 Hyundai Tuscon SUV (FL TAG #EJDE56) eastbound on Cleveland St W (head-on into traffic), approaching the intersection of Howard Av S. This section of Cleveland St W is a 1-way roadway, with westbound traffic only. This also occurred on a busy Friday night in the Soho bar district, with heavy vehicle and pedestrian traffic. During the traffic stop for the wrong-way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, appeared tired/lethargic, moved with slow & deliberate movements, had poor balance, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she was read Implied Consent, but refused to provide a breath sample upon request.
