The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, at the Walmart located at 8220 Dale Mabry Hw. N., the defendant was observed by the witness via video surveillance. The defendant selected merchandise throughout the store and proceeded to the self-checkout. While at the self-checkout and while scanning items, the defendant intentionally placed items inside a grocery bag without scanning the items. The defendant also scanned selected items and failed to scan others "Skip-scan." The defendant proceeded to pass all points of sale in an attempt to permanently deprive the business of the merchandise, making no attempt to render payment for the unpaid merchandise. The total value of the unpaid merchandise was valued at 47.31. The defendant did not qualify for the Adult Pre-Arrest Diversion Program (APAD) since the defendant did not admit to the offense and would not participate in the program. The defendant was positively identified via her Florida Driver License.
