The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was being trespassed from the Gold club at the above location when Officers advised the defendant that she was under arrest for trespass after warning. When officers attempted to go hands on with the defendant to place her under arrest. The defendant actively pulled away from Ofc. Curbelo and was actively pulling her arms out of Ofc. Curbelo grip, resisting Ofc. Curbeloss attempts to place hand cuffs on her. As the officers were attempting to take the defendant to the marked patrol vehicle, the defendant had to be assisted due to her dragging her feet and not walking of her own power. While sitting in the back of the patrol vehicle, the defendant was was not listening to verbal commands to put her feet back into the vehicle after several commands by Ofc. Curbelo. The defendant kicked Ofc. Curbelo with her foot twice on Ofc. Curbelo right thigh, which was against her will. The defendant was highly intoxicated and was shouting verbal profanities to the patrons of the bar and officers during the arrest.

When the defendant was transported to HCSO booking facility and detention deputies were searching the defendant, they located inside the defendants bra a small clear plastic baggie containing a white powdery substance. Which was tested with an agency issued field test kit, and came back positive for cocaine.

The defendant was positively identified via DAVID photograph.
