NARRATIVE:

On July 28, 2020 at approximately 2145 hrs., Agents from the Palm Beach County Sheriff's Office Interdiction Unit executed a lawful search at 421 N 5th street apt. 1 Iantana, FL. While executing the warrant Agents came in contact with a white female later identified as ALEXIS LEE BUCKLIN. BUCKLIN was identified as the sole occupant of the apartment. Agents ordered BUCKLIN out of the apartment and began to search it for officer safety. Before Agents began to search the apartment BUCKLIN made an spontaneous utterance by saying there's gun inside. BUCKLIN also state she had smoked two blunts earlier, referring to marijuana cigarettes. As agents began searching and rendering the apartment safe, they observed raw marijuana and marijuana cigarettes in the kitchen area and the bedroom belonging to BUCKLIN. Agents also observed a Glock semi-automatic on top of a dresser.

I, Agent [REDACTED] responded to the area where BUCKLIN was being held and read her Miranda warnings. I asked BUCKLIN if she understood those rights. BUCKLIN responded yes. During the interview BUCKLIN stated she had smoked two marijuana blunts (cigarettes) and stated the gun belong to a friend or roommate. I asked BUCKLIN about answering the door. BUCKLIN was also asked about an incident that happened earlier in the afternoon. BUCKLIN stated she did not remember what she had done in the afternoon. I informed BUCKLIN agents observed her participate during the delivery of a parcel containing suspected narcotics and if she could provide information about. BUCKLIN took a pause, looked down, began crying and said she needed to use the restroom. BUCKLIN was informed a female deputy was in route to assist while she went to the restroom. After the arrival of the female deputy BUCKLIN escorted inside apartment and instead of using the restroom attempt to make a phone call to an unknown person. The interview was concluded based on BUCKLIN lack of cooperation and as she became verbally abusive.

NARRATIVE CONTINUATION

Agents concentrated their efforts in searching the apartment and located the following evidence-

- Marijuana in a clear baggie and loose marijuana on top of the kitchen counter next to BUCKLIN social security card, adult entertainment card, visa card and U.S Currency.

- Grinders on top of microwave
- A glock semi- automatic handgun on top of a dresser and near marijuana blunts (cigarettes). The firearm was also located near prescription bottles containing BUCKLIN name on them.
- Correspondence with BUCKLIN name written on it.
- A ruger semi- automatic handgun under BUCKLIN bed.
- A marijuana blunt (cigarette) and loose marijuana on metal trade.
- All currency was also seized.

Based on the above facts BUCKLIN was arrested for possession of marijuana under 20 grams per F.S.S 893.13(6)(B).
