The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 11/01/2019, at approximately 2137 hours, the defendant was operating a 2008 grey Toyota Corolla bearing FL tag 1896BU (VIN:2T1BR32E18C866848) on Keystone Crossing Bl, at the gate for Keystone Manor. The defendant tried to reverse and struck a metal street sign. The collision resulted in damage to the rear of the vehicle, and a popped front driver side tire. The defendant then left the scene on Gunn Hw. Deputy Spanier, while approaching the scene, observed a vehicle matching the description driving on Gunn Hw. Deputy Spanier observed sparks coming from the driver side tire, and conducted a traffic stop. Upon approach, Deputy Spanier observed the defendant operating the vehicle as the driver and sole occupant. Deputy Spanier spoke with the defendant and observed indicators of impairment. A witness to the collision positively identified the driver of Deputy Spanier's traffic stop as the defendant, and as the person operating the Toyota at the time of the traffic crash. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. After a proper 20 minute observation, the defendant provided a breath sample which resulted in a BAC of .139/.143. The defendant was identified via FL DL. Per DAVID, The defendant's FL DL has been suspended since 12/11/2018. In addition, it was discovered the license plate attached to the Toyota was unregistered and not assigned to the vehicle. Post Miranda, the defendant advised she knew her FL DL was suspended and knew the plate attached to the Toyota did not belong on the vehicle.

Damage as a result of the crash is valued at approximately \$1,000.
