The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08/23/2020, at approximately 0045 hours, near the Amscot's parking lot which is located at 10481 Gibsonton Drive, Riverview, Florida 33578 Sergeant B. Hartz ABN: 217045 observed the defendant in physical control of a silver 2015 Nissan Versa bearing Florida tag IF50UA with an assigned VIN of 3N1CN7AP2FL941824. Sergeant Hartz observed he defendant sitting in the running vehicle in the driver's seat. After further investigation, Sergeant Hartz observed multiple indicators of impairment from the defendant. Sergeant Hartz originally responded to the area reference a reckless driver call for service. Upon the affiant's contact with the defendant, I smelled the strong odor of an alcoholic beverage emitting from her breath, she had bloodshot watery/glassy eyes, and she was slightly unsteady on her feet. The defendant refused to participate in field sobriety exercise. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was transported to Central Breath Testing, where she refused to provide two lawful breath samples. The defendant was read Implied Consent and she continued to refuse by stating "No." The defendant identified herself verbally. I further identified the defendant via her DAVID photograph.
