The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 03-24-2021, located within Hillsborough County (1422 Millerman Pines Dr. Tampa FL. 33612), the defendant and victim 1 (Saeideh) engaged in a verbal altercation. Victim 2 (Shervin) attempted to break up the verbal altercation between the defendant and victim 1. The altercation turned physical, when the defendant knowingly and intentionally struck victim 2 in the head with a plasma TV against victim 2's will. Victim 2 suffered minor injuries (bruising to forehead and small laceration to finger and hand due to broken glass from TV) and did not need medical assistance at this time. Victim 1 attempted to interfere with the physical altercation between the defendant and victim 2, when the defendant intentionally and knowingly struck victim 1 on the left side of her face with an open hand against her will. The defendant then knowingly and intentionally pushed victim 1 against the wall and threaten to hit her against her will. The defendant obtained a knife from the residence and threaten to kill both victims, which victim 1 advised she was in fear for her life. It should be noted, the defendant had the ability to commit an offense using the knife during the time of the incident. Victim 2 attempted to call 911 when the defendant intentionally took the phone from victim 2, to prevent victim 2 from calling 911. The defendant and victim 1 have a child in common, which is victim 2, and all parties reside together as a family. Both victim 1 and victim 2, identified the defendant as the one who committed the offense. The defendant's identity was confirmed via FL DL S162000831070.
