Upon my arrival I made contact with a white male matching that description. It should be noted his right eye appeared freshly swollen and he had fresh scratch marks on the right side of his face and on both of his forearms. Ofc. J Martinez made contact with a white female who matched the previous description.

Upon speaking with the male, who was later identified as Bobby W. Tabor (W/M, DOB 1/1/1972), he stated he was in an argument with his wife, Alissa Youngblood (W/F, DOB 12/28/1988). Tabor stated they had been married for three years, had no children in common, and had been living together for three years. Tabor stated he was in an argument with Youngblood because she thought he was cheating on her when he gave her the wrong room number. When I addressed the injuries to Tabor's eye, cheek, and arms, he stated "We are from Kentucky, we fight and we fuck." Tabor was unable to provide a valid explanation as to how he received his injuries and who caused them. Tabor then became visibly frustrated and refused to cooperate any further.

(Post Miranda) Youngblood stated she was arguing with Tabor because he gave her the wrong hotel room number. She thought he was cheating on her. Youngblood denied the argument ever becoming physical or ever striking Tabor.

Tabor showed multiple fresh injuries on his eye, cheek, and arms. He stated he has been married to Youngblood for three years and living together for three years, with no children in common. I find probable cause exists to charge Alissa Youngblood (W/F, DOB 12/28/1988) with F.S.S. 784.03(1A1) Simple Battery (Domestic). Youngblood was transported to Palm Beach County Jail and booked without incident.
