The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 5/20/2020 at approximately 2022 hours, the affiant responded to the intersection of Lakeside Cove Ct / Meadowlake St in reference to a health & wellness check. Upon arrival, I observed a white in color Dodge Caravan bearing FL tag Z576IH parked, with the vehicle running, and a female driver asleep leaning against the driver's side window panel. Upon asking the driver if there was anything illegal in the vehicle, the driver spontaneously gave Dep. Kleiner (ABN 255453) two plastic baggies containing a green leafy substance. The driver identified the green leafy substance as "marijuana". Search incident to arrest of the vehicle, a container bearing the words "trap snacks" was located behind the front passenger's side seat floor board. Inside the container was a multi-colored coated gummy style candy. On the glass container, the label related the following "THC, For medical and recreational use". The affiant then tested the multi colored gummie using a 1% THC field reagent kit which yielded positive results for THC. The defendant stated Post Miranda: "I do not have a medical marijuana card", "Those are THC gummies". The affiant identified the defendant via her FL issued driver's license.
