On the <u>18</u> day of <u>September</u>, <u>2021</u> at <u>18:12</u> (Specifically include facts constituting cause for arrest.) On September 18, 2021, at approximately 18:12 hours, I responded to assist the Jupiter Police Department in locating a suspect vehicle that was involved in a hit in run in their jurisdiction. Please see Jupiter Police Department's report (). My department issued body worn camera was utilized during this investigation. While canvassing S.R. 811 (Alternate A1A) southbound, I located the suspect vehicle, a white Grand Cherokee bearing Florida temporary tag DAI2106, traveling southbound near Gardens Parkway and Alternate A1A. I attempted to initiate a traffic stop, in my fully marked and department issued vehicle with overhead lights and siren, at the intersection of Kyoto Gardens Drive and Alternate A1A while the vehicle was still traveling southbound in the left lane. The vehicle continued southbound without changing speed until it come to a light that had just turned red at RCA Boulevard and Alternate A1A. The vehicle still did not yield and attempt to pull over and stopped in traffic, with my lights and siren still activated. I approached the vehicle quickly and knock on the driver's side window to which the driver, Alycia Kraft, rolled down a quarter of the way down. I told Kraft to turn her vehicle off, to which she closed the window and refused to turn the vehicle off. Officer's Eriksson and Stairs arrived on scene and continued to assist in trying to get Kraft to roll her windows down and turn the vehicle off. It should be noted the Kraft also locked her vehicle doors so that Officer's could not open the door. Officer Stairs was able to get Kraft to roll down her passenger window a quarter way down and het her to roll the driver's side window down. At this time Officer Eriksson reached into the vehicle, opened the door from the inside and the female was removed and placed into handcuffs, which were checked for fit and double locked. The entire time, Kraft was resisting the lawful orders of uniformed Law Enforcement Officers. While attempting to get the female to comply, Officers noted that Kraft was moving

slowly and when the door was opened, this Officer could smell the odor of an unknown alcoholic beverage emanating from her person. While being detained in the rear of my patrol car, Kraft had mood swings and became extremely emotional.

I read Kraft her Miranda Warnings and she stated she understood but did not want to talk to me. While sitting in my vehicle, Kraft began to talk freely to me and told me that she did not see the flashing Police lights or hear my audible siren while I was behind her for approximately .62 miles.

Due to the totality of the circumstances, I find there to be probable cause to charge Kraft with Flee and Elude pursuant to Florida State Statute 316.1935(2) and resisting an officer without violence pursuant to Florida State Statute 843.02.

Kraft was turned over to the Jupiter Police Department for their investigation and subsequent arrest.
